AMENDMENT TO DECLARATION OF CONDITIONS, COVENANTS, RESTRICTIONS, EASEMENTS AND CHARGES AFFECTING THE REAL PROPERTY KNOWN AS PINON VALLEY FILING NO. 6

2. Section 403(i) is amended to read as follows:

3. Except as amended herein, Declarant hereby ratifies, confirms and approves the Declaration.
