## KEEPING OUR NEIGHBORHOOD SAFE

Our Neighborhood Watch Program was implemented in Green Valley Ranch during the summer of 2005. A little over 50% of our 112 homeowners have joined. Have you?

The Neighborhood Watch Program is a cooperative effort between homeowners and the police department making communities more inviting and safe thus less attractive for criminals. The program is not new and can be found throughout the United States. It is what neighborhoods have done for years. It is simply being a good neighbor, supporting each other and watching strangers who suddenly appear in the neighborhood.

Being a member is not dangerous and takes very little time. Watch members are asked to:

- Be alert to suspicious activities of strangers in your neighborhood.
- Learn the names of your neighbors and be able to identify their vehicles and other vehicles usually in the neighborhood.
- Notify the police and Block Captain of any suspicious activity.
- Take an active interest in staying informed in making the neighborhood safer.

Neighborhood Watch members receive a roster with names and numbers of other members. They also receive periodic crime prevention information and crime statistics. But most important it helps keep our neighborhood safer. # State of the HOA

As we look back on 2014 it was a less eventful year with no fires and I know we are all thankful for that! And the work that was done on the drainage channel seems to have worked because even with the heavy rains we had no flooding issues for those of us who back up to it.

Financially we were able to manage the HOA and mange to keep our expenses below our budget. Our trash removal expenses did increase slightly based on our three-year contract with Bestway but our property insurance did not increase. We also started purchasing our services from our landscaping company on an a la carte basis. By doing so we were able to cut our costs and still maintain the landscaping and keep the weeds down.

One change the Board made this year was to change the due date for our annual payments from February 28<sup>th</sup> to January 31<sup>st</sup>. We made this change to improve the timing of our cash flow and hopefully reduce the number of late payments. We are now on quarterly payments for our trash service and getting the annual dues in sooner will help making that payment in February. You still have a grace period until the end of February before any late charges will be assessed. With the previous due date of February 28<sup>th</sup> we were not receiving payments until March.

The Annual Meeting will be held February 26<sup>th</sup> at 6:30 pm at the Fire Station behind the Walgreens. As usual we will discuss the financials from 2014, present the budget for 2015 and give you an update on the HOA. We also have 4 Board positions for you to vote on so if can't make it to the meeting we hope you will return the ballot with your payment.

A big thank you goes out to Sue Roth for putting together the newsletter again this past year. We have been sending it out electronically to save on printing costs so please be sure to give us your email address if you want to receive it. There is a space on the invoice for you to give us your information.

And thank you goes out to all of you for being great neighbors and continuing to take care of your homes and making our neighborhood such a nice place to live.
